## SCARP Alternatives Evaluation – Preliminary Screening of Alternatives (Approval)

Ms. Mandes referred to the attached memorandum, briefly explaining the need for screening alternatives by Malcolm Pirnie. This task is part of the Infiltration and Inflow program that the Authority has been working on. She noted that the goal of this task is to narrow down the many different combinations of rehabilitation methods to address the current and future peak and dry weather flows. Some discussion followed. After some inquiry from Board members, Ms. Mandes stated that the EPA Administration Order would like SSOs eliminated by 2014; however, the SCARP program is rather intensive and will most likely stretch over a 10 year period.

On a motion from Mr. Bieber, seconded by Ms. Cusick, the Board unanimously approved a Capital Project Authorization Amendment, which includes a Professional Services Authorization, for Malcom Pirnie for \$225,000 (6-0).

## Lehigh County Authority Wastewater Treatment Plant Annual Report Presentation

Ms. Mandes referenced the attached presentation regarding the LCA WTP. Ms. Mandes gave an overview of the revenues and expenses for 2012 at the WTP, noting that both revenues and expenses increased in 2012, but overall, the WTP is doing well.

Mr. Haberstroh continued the presentation, providing specific information regarding plant operations, upgrades to the plant throughout the year and new projects that are needed in 2013 to improve plant operations. Some discussion followed.
