## LCA Customer Notice - 2022 Suburban Water Rates!

Starting January 1, 2022, Lehigh County Authority's Suburban water rates are increasing by \$18.75 per quarter (\$75 annually) for most residential customers. Commercial / industrial customers will notice higher increases due to high water volume usage.

Special Notice: Customers on Welshtown Road will see no changes in your water bill at this time.

Why are Rates Increasing? LCA's 2022 Budget outlines a need for ongoing repair and replacement of aging infrastructure like water mains and storage tanks. Because these improvements will occur annually, the expenses must be covered through the rates. This will limit the need to borrow for these projects in the future and will have a long-term benefit of controlling future rate increases. The 2022 rate increase also covers increased costs for labor and materials, insurance, water supply costs, technology upgrades, and improved preventive maintenance and asset management programs. Revenue generated through the rates is invested directly back into the system in the form of rehabilitation, preventive maintenance, and improvements.

**LCA Water Rate Explanation:** Your water bill includes a fixed charge and a volume charge.

Volume Charge	\$41.40 (\$2.76 per 1000 gallons)	\$48.90 (\$3.26 per 1000 gallons)
Total Quarterly Bill	\$61.45	\$80.20
