## **LCA Customer Newsletter**

## January - March 2023

Starting January 1, 2023, Lehigh County Authority's Suburban water rates are increasing by approximately \$4.80 per quarter (\$19.20 annually) for most residential customers. Commercial/industrial customers will notice higher increases due to high water volume usage.

Special Notice: Customers on Welshtown Road will see no changes in your water bill at this time.

**What about sewer rates?** If you receive a sewer bill directly from LCA, there are no changes to your sewer rates for 2023. If you receive a sewer bill from the municipality where you live, not from LCA, please check with your municipality to learn more about their sewer rates for 2023.

Why are water rates increasing? LCA's 2023 Budget outlines a need for ongoing repair and replacement of aging infrastructure like water mains, storage tanks, and system upgrades. We expect our local need for infrastructure improvements to be well in excess of \$200 million over the next 10 years. As a utility and a community, we must be prepared for continued increases to our water and sewer rates to meet these system needs. The decision to raise rates is weighed carefully against the long-term needs of the system so that we can fulfill our mission to protect public health and the environment.
